

# Two-stage registration for the 11-12 October 2025 RES examination

## Stage 1: Indication of Interest (1 September 2025, 9 am to 12 noon)

- Applicants must have a valid RES course completion certificate and have completed their RES course by **31 August 2025** to be eligible.

- Please note that a submission of interest does not mean a confirmation of an examination seat.
- All applicants accessing the form will first be directed to a waiting room. After Singpass authentication**, applicants will be admitted into the form based on the order/time in which they first click on the FormSG link and enter the waiting room. (Refer to the FAQ for more information.)
- Applicants are advised to access the form using personal devices with the latest version of the internet browser. Do not use employer-issued devices with security features installed to access the form to avoid experiencing access issues after Singpass authentication.
- Applicants who meets the eligibility criteria will be shortlisted on a **first-come, first-served basis based on the timestamp of their form submission**.
- Information required: A valid and working **Singpass account for authentication**, full name as shown on your NRIC/FIN, contact number, and email address. Ensure you have **access to your email inbox to receive a one-time password (OTP)** for verification of your email address.
- Select either Full or Modular sitting\* *Modular sitting applies to an applicant who is exempted from Paper 1 of the RES examination OR has a valid pass for one of the papers.* **Applicants will be disqualified if they choose the wrong examination type or submit more than one form. Only one submission per NRIC/FIN is allowed.**

## Stage 2: Examination Registration & Payment (11 to 14 September 2025)

- NTUC LearningHub (LHUB) will contact shortlisted applicants via email **by 10 September 2025** to provide instructions on completing the examination registration on LHUB's website from 11 to 14 September 2025.
- Shortlisted applicants are required to upload supporting documents and make payment online to complete the examination registration.
- Applicants will see the following message upon successful completion of the exam registration and payment.

- Shortlisted applicants who do not complete the examination registration by LHUB's Stage 2 deadline will have their seats released to those on the waitlist.
