

Key Features of the New CPD Framework

Current	New
6 CPD credit hours	6 credits
6 CPD credit hours, of which 3 must be core subjects	4 Professional and 2 Generic CPD credits per year
C1, C2, C3 over 3 consecutive cycles	Requirement removed
No mandatory CPD courses	Mandatory courses may be introduced as and when needed



Transition CPD Requirements From Now Till 30 Sep 2019

✓ Fulfil CPD1 requirement for 2019 CPD cycle

6 CREDIT HOURS, AT LEAST 3 ON CORE SUBJECTS

✓ Waiver of CPD2 requirement

C1, C2, and C3 course under 3 consecutive CPD cycles
